St. Cloud operates under a Council/Manager form of government. St. Cloud City Council consists of a mayor and four council members elected by the registered voters of the city. City Council oversees the City Manager, City Attorney, Lobbyists, Auditors and Boards/Committees.

City Manager's Office

The City Manager is the City's chief administrative officer and is responsible to the City Council for all affairs of the municipality.

City Clerk's Office

The City Clerk is the custodian of the seal of the municipality and of all records pertaining to the affairs of the City. Staff coordinates the preparation of the City Council agendas and ordinances, resolutions and proclamations, and manages public records requests. **407-957-7320**

Economic Development

This office helps promote the economic health of the city of St. Cloud, manages key economic development projects and programs and is the liaison between City of St. Cloud and St. Cloud Chamber of Commerce, St. Cloud Main Street, Inc., and the business community. **407-957-7234**

Public Information Office

The Public Information Officer helps create public awareness of the municipality's activities, programs and services, and responds to media inquiries. **407-957-7303**

Purchasing Division

Staff manages procurement services while maintaining adequate support of the municipality's needs for materials and services, vendors, procurement cards, bid notifications and auctions of surplus materials.

Finance

This department budgets, manages, controls, invests and oversees the financial affairs of the municipality. The director advises City Council and City Manager of possible actions, coordinates audits and manages the City's investment portfolio. The director oversees the accounting, administration and grants divisions, and St. Cloud Utilities Billing. **407-957-7311**

Fire Rescue

St. Cloud Fire Rescue strives to achieve its mission to protect the lives and property of citizens and visitors by providing the highest level of service through fire prevention, public education, fire control and emergency medical services. SCFR manages three fire stations. **407-957-8480**

Growth Management Services

Building

This department's responsibilities include permitting, plans review, inspections for code violations, new business inspections and garage sale permits. Licensing responsibilities include issuing and renewing contractor registration, issuing business tax receipts, issuing certificates of use, renewing licenses and enforcement of codes. **407-957-7224/7282**

Community Redevelopment Agency

Parks and Recreation

This department provides a variety of recreation programs and opportunities for the residents of St. Cloud and oversees facility rentals, community parks, Chris Lyle Aquatic Center, Mt. Police Department

More than 145 sworn officers and employees help protect the lives, property and rights of all people with courage, compassion and integrity. St. Cloud Police Department oversees Communication Center, Code Enforcement and Emergency Management. Public Services

Environmental Utilities provides potable water, reclaimed water and sanitary sewer collection and treatment to the city of St. Cloud and surrounding areas that fall within the City's utility service area. Provides utility services to St. Cloud Utilities customers. Promotes conservation and protects natural resources through environmental education and practices. **407-957-7344**

Public Works plans and provides for safe and efficient traffic circulation; serves city residents with efficient and timely single-stream curbside recycling services and solid waste collection and disposal. The Solid Waste compound (Transfer Station at 2705 PegHorn Way) is a modern facility that can handle large items including furniture, kitchen appliances and hot-water heaters. Other Public Services responsibilities: streets, solid waste, utilities engineering, lines, instrumentation/electric division, civil engineering, stormwater utility, turf and landscaping, traffic control and City vehicles' maintenance. **407-957-7344**
