OVERVIEW

The St Cloud Fire Rescue provides a variety of services to the community. These services include four major areas of responsibility. They consist of:

FIRE RESCUE EMERGENCY RESPONSE

- Response to structure fires, search and rescue and vehicle/machinery extrication
- Initial hazardous materials incident response
- Technical Rescue including: extrication, confined space, and elevated rescue.
- Wildland and urban interface fires
- Natural and man-caused disasters

EMERGENCY MEDICAL AND TRANSPORT SERVICES

- Basic and Advanced Life Support Response
- Medical transport
- Response to mass casualty incidents
- Response to pandemic, biological, or other related bio events

FIRE PREVENTION THROUGH THE OFFICE OF THE FIRE MARSHAL

- New Construction inspections
- Existing facility life safety inspections
- Enforcement of code compliance
- Plans and blue print review
- Tent, burn, pyrotechnic, and special event permitting
- Nuisance false alarm investigations
- Fire/Arson investigations

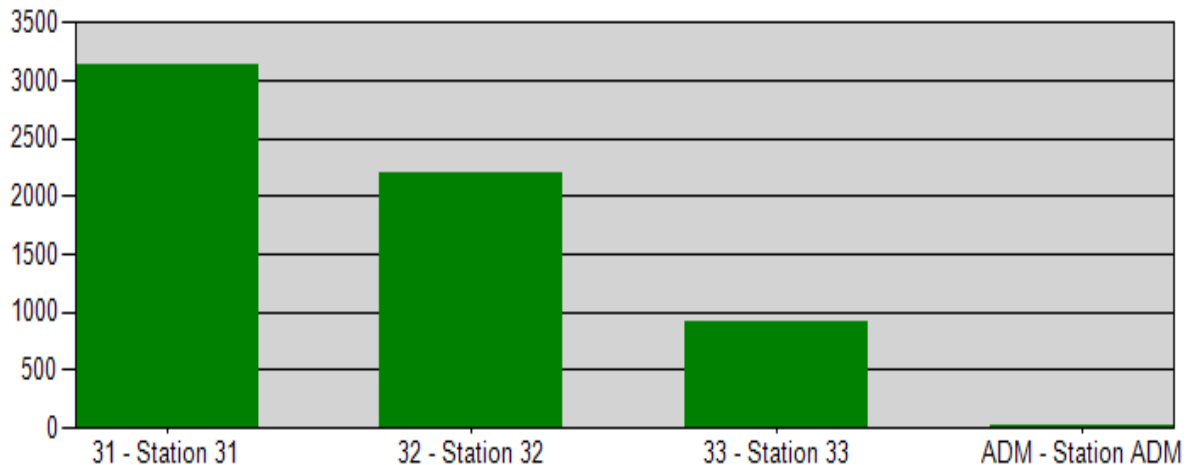
PUBLIC EDUCATION AND COMMUNITY RELATIONS

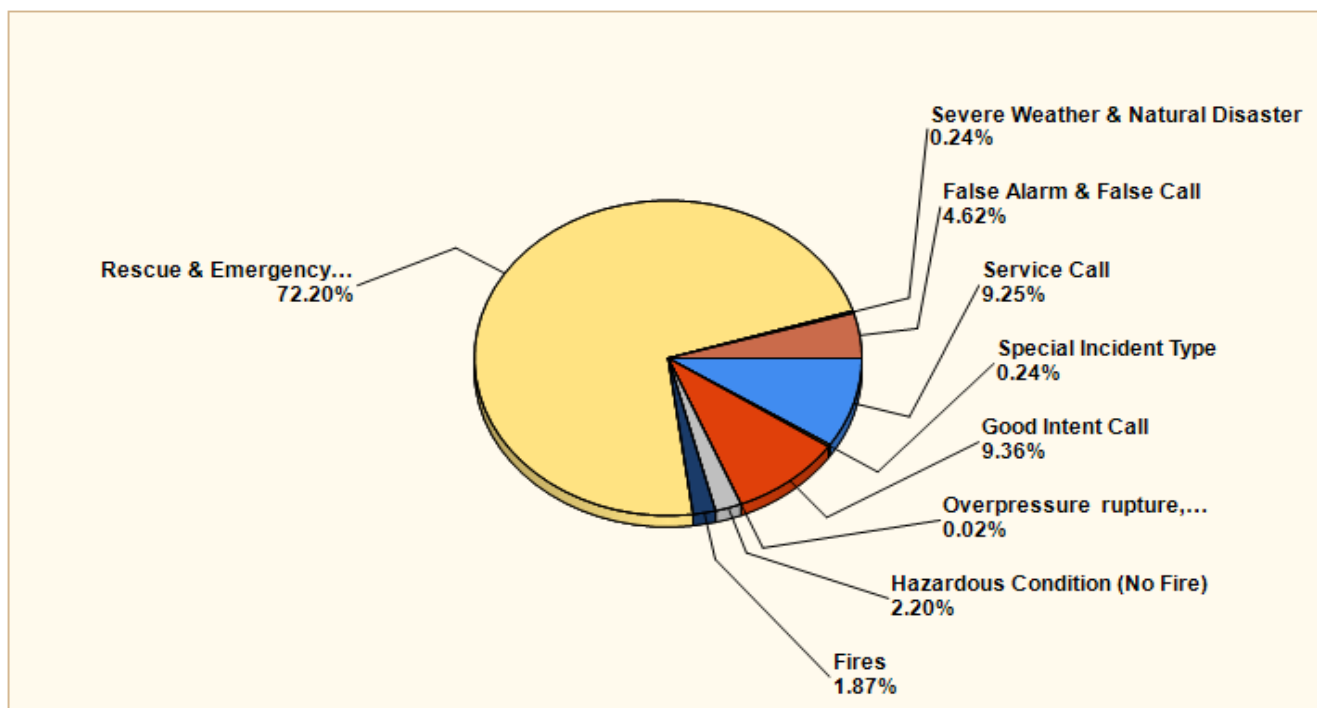
GENERAL FIRE/EMS RESPONSE DATA
