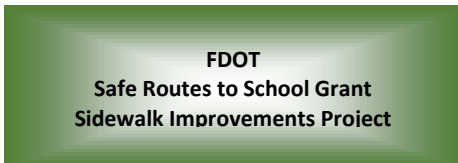


Grants Division – Procurement Services Department 2017 Year End Report

Top Accomplishments:

- Completed the 2017-2018 Community Agency Grant Application Cycle distribution of \$140,000 in award funding to 30 Community Service Agencies
- Completion of the SRTS (Safe Routes to School Design) Grant for construction of the Lakeview Elementary, Michigan Ave Elementary and St. Cloud Middle School Sidewalks
- Grants Administrator held interviews and extended an offer of employment for a part-time Grants Assistant position; that person started September 13, 2016.

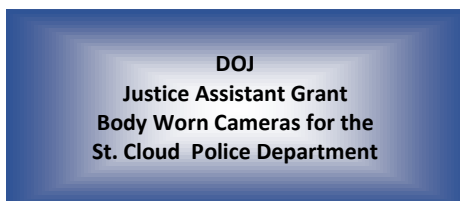
